Senior League Consultation – Player Survey Data

As part of the Senior League review, the 2023 Player Survey data was analysed, across the three key areas identified by the Rules & Playing Conditions Workstream:

- 1. Start times
- 2. Match Format
- 3. Game Length

As well as the above preferred Travel Time data was also investigated. The survey data was broken down into the following groups, to understand the opinions of the players within the different leagues and Tiers of the current structure:

Surrey Championship Tier 1 (1 st XI Premier Division and Division 1)
Surrey Championship Tier 2 (1 st XIs Division 2-5)
Surrey Championship Tier 2 (2 nd XI Premier Division)
Surrey County League (1 st XIs – All Divisions)
Surrey Championship Tier 3 (2 nd XIs Division 1-5)
Surrey Championship Tier 3 (3 rd XI Premier Division)
Surrey Cricket League (All Divisions)
Surrey County League (2 nd XIs – All Divisions)
Surrey Championship Tier 4 (All 3 ^{rd,} 4 th , 5 th & 6 th XIs, except for 3 rd XI Premier Division)

Start Times

The survey asked for the respondents preferred start times. The options were given in hourly increments and the results are as follows:

As per the table 12pm was the preferred start time for most respondents, followed by 11am. One major factor to consider outside of the survey results is the impact earlier start times have on junior cricket. Another consideration is that the survey format only offered the option of hourly increments. It is important to consider what impact offering half hour options (i.e. 12.30pm) would have on the results.

Formats

The survey asked participants which format they preferred to play:

- 1. All Limited overs
- 2. All Declaration
- 3. Split Season (Half Limited Overs, Half Declaration)
- 4. Other

The results are as follows:

Match Length

The question on match length was linked to that of preferred format, so respondents only answered the question in relation to their preferred format. This meant that there were more respondents to the question on the number of overs in limited overs matches, rather than the declaration format. The results are as follows:
