# League Structure (as per SCC Constitution)

Tier 1 – Premier Level and Level 1 (ECB Premier League regulations apply)

Tier 2 – Levels 2 to 5

Tier 3 - Levels 6 to 9

Tier 4 - Levels 10 and below

# 1. Background

Developing and maintaining the best possible facilities for clubs is a key factor in driving an enjoyable experience for players, officials and spectators. As such, SCC encourages all Member Clubs to seek to provide the best possible facilities for their members.

The requirements at the higher end of the structure are in place to facilitate some of the highest levels of recreational cricket played in the country, with the very top level is played to ECB Premier League standard with overseas and contracted players participating in games alongside strong domestic players and hence the quality of the playing surfaces need to be as high as possible. SCC encourages clubs to focus on a 'Get The Game On' approach to facilities further down the structure, being flexible and pragmatic where necessary to enable games to be played in an enjoyable but safe manner.

#### 2. Facilities for All

Member Clubs should be aware of their on-going duties under the Equality Act 2010, including to make reasonable adjustments to services so that employees, members and guests (including all players, official and spectators) have access to their grounds, facilities and social spaces, irrespective of social status, age, disability, sex, sexual orientation, gender, gender reassignment, marital or civil partnership status, pregnancy, maternity, race, religion or belief.

### 3. Meeting the Requirements

As required in the SCC constitution, all Member Clubs must meet and maintain the minimum accreditation criteria as specified in this document. Failure to meet these standards may result in a team not being granted promotion into the next Level.

Many requirement are mandatory for teams playing in Tiers 1 & 2, whilst teams participating in Tiers 3 & 4 are encouraged to work towards meeting many of the recommendations.

Teams seeking to progress between Tiers should review the requirements, identifying any key areas that require action in order for a club to be permitted promotion into the next Tier up. Teams participating in Level 2 (at the top of Tier 2) and Level 6 (at the top of Tier 3) of the structure in any given year may be assessed so they are aware of any work that is required to meet the standards at the next Level so that steps can be taken to address any outstanding elements ahead of a possible promotion.

### 4. Use of Grass/Hybrid and/or Artificial Pitches

All games played in Tiers 1 and 2 must be played on grass or hybrid pitches.

At Tier 3, the use of grass or hybrid pitches is strongly encouraged, though consideration will be given to clubs seeking to play on an artificial pitch. Clubs seeking to do this should write to the SCC Co-ordinator to request permission to do this before 1<sup>st</sup> April of any given season.

At Tier 4, teams are permitted to use non turf pitches, but this must be declared to the SCC Coordinator in writing before 1<sup>st</sup> April of any given season.

## 5. Requirements

Requirements are listed in the following table. Any applications for exceptions must be made to the SCC Coordinator in writing before 1<sup>st</sup> April of any given season.
